Licensing Information

Shaun Vining Limited (FSP778357) holds a Class 1 licence issued by the Financial Markets Authority to provide financial advice. Shaun Vining (FS756411) is authorised by that licence to provide financial advice.

Nature & Scope of Advice

Shaun Vining of Shaun Vining Limited provides advice to clients about their Life, Trauma & Disability and Health insurance and ACC structuring. Shaun Vining Limited provides financial advice in relation to these financial advice products:

Shaun Vining Limited only provides financial advice about products from certain providers:

- For Life, Trauma & Disability insurance, I work with five providers:
 - AIA, Asteron Life, Chubb life, Fidelity Life and Partners Life.
- For Health insurance, I work with four providers:
 - Accuro, AIA, NIB and Partners Life.

In providing you with financial advice, we will consider both your existing and unmet personal risk needs. We will not provide advice on existing whole of life or endowment products, so you will need to consult a specialist if you would like advice on those products.

Other Services

Where Shaun Vining cannot provide advice on products such as Mortgages, Investment and Fire & General Insurance, he has referral agreements in place that may see him being compensated should you choose to work with these Partners. This will be explained to you before you are referred and will also be documented in the Advice Report.

Fees & Conflict of Interest

Shaun Vining from Shaun Vining Limited may charge a fee for the financial advice provided to a client where no compensation for work done is received from a provider. Any fees that will apply to an engagement will be explained and agreed with the client beforehand. Shaun Vining receive commissions from the providers on whose products he provides financial advice (the insurance providers).

I do not charge you a fee if you decide to take out an insurance policy following my advice. The insurance provider will pay me a commission if you decide to take up my advice. If you decide to take out insurance, the provider will pay a commission to Shaun Vining Limited, your financial advisor. The amount of commission is based on the amount of the premium. From time to time, product providers may also reward us for the overall business we provide to them. For example, they may give us fruit baskets, hampers, or other gifts. To ensure that we prioritise the client's interests above our own, we follow an advice process that ensures our recommendations are made on the basis of the client's goals and circumstances. All staff undergo annual training about how to manage conflicts of interest. We maintain a register of any conflicts of interest, and we also have annual compliance auditing processes in place.

However, if you cancel or reduce your insurance policy within the first two years of its inception, the commission earned (or part of) is required to be repaid to the Insurance company. Therefore, if you cancel or reduce your policy within the first two years, I reserve the right to charge you a fee for the financial advice I have provided as follows: Advice fee = The lesser of \$500 + GST or the actual commission claw back. I will invoice you for this fee and it will be payable on the 20th of the month following the cancellation of your policies. Details of how to make payment will be included on the invoice.

Complaints

If you are not satisfied with the financial advice service you have received, you can make a complaint by emailing shaun@shaunvining.co.nz or by calling Shaun Vining directly.

You can also write to our office at 1 Fisher Road, Kakapuaka, Balclutha, 9273. When we receive a complaint, we will consider it following our internal complaints process. We will consider your complaint and let you know how we intend to resolve it. We may need to contact you to get further information about your complaint.

We aim to resolve complaints within 10 working days of receiving them. If we can't, we will contact you within that time to let you know we need more time to consider your complaint. We will contact you by phone or email to let you know whether we can resolve your complaint and how we propose to do so. Shaun Vining Limited keep a complaint register and is part of Insurance & Financial Services Ombudsman (IFSO) which provides a free independent dispute resolution service. If we cannot resolve your complaint, you can contact the IFSO to resolve any disagreements,
